**BUDGET SPEECH BY CLLR MBOOTHOMA MADUNA, THE MAYOR OF SETSOTO LOCAL
MUNICIPALITY, COUNCIL CHAMBER
27 MAY 2010 AT 10:00**

I would like to take this opportunity to convey my heartfelt greetings to our distinguished guests, Council and Exco Members, Senior Management, all our Municipal Officials and our audience in attendance this morning. Allow me on this occasion of the penultimate sitting of the Council of Setsoto, to wish all Honourable members, a happy and productive financial year before the Local Government Elections of 2011. I say **‘BON VOYAGE.’**

Let me begin by citing a letter written by Dr Martin Luther King Jr. from Birmingham Jail on April 16, 1963. “While confined here in the Birmingham city jail, I came across your recent statement calling my present activities “unwise and untimely.” Seldom do I pause to answer criticism of my work and ideas. If I sought to answer all the criticisms that cross my desk, my secretaries would have little time for anything other than such correspondence in the course of the day, and I would have no time for constructive work. But since I feel that you are men of genuine good will and that your criticisms are sincerely set forth, I want to try to answer your statements in what I hope will be patient and reasonable terms.”

It must be noted that, the culmination of 2010/2011 budget is indeed absolutely another significant milestone for Setsoto Municipality after we have interacted with our communities to enable them to make their contributions to our Integrated Development Plan (IDP). The budget speech is primarily informed by the priorities that our communities have advised us to consider as this Municipality.

Ke rata ho phetha hape jwalo ka tlwaelo ke re, re fela re fihletse katleho ho tse ding tsa dikateng tseo tokomane ya ditekanyetso ya selemo 2010/11 e neng e di behile. Re ikemisedisetse ka matla a maholo hore re se ra hlola re eba le mathata a nako e fetileng.

We have taken a conscious decision to ensure that we continue with effort of ensuring that, local government works better and works better for our people by ensuring that there is provision of basic services to our people progressively with our limited resources.

Our budget for the financial year of 2010/2011 has been prepared and compiled within the confinements of National Treasury's requirement.

Hon. Speaker, I would further appreciate to take this opportunity to state that, we have complied with the Municipal Finance Management Act, 2003 (Act No. 56 of 2003) and Municipal Systems Act, 2000 (Act No. 32 of 2000) in compiling this budget. It is strictly and directly aligned to the Integrated Development Plan (IDP).

Hon. Speaker, as the country we have just observed the **National Child Protection Week**, that started on 25 May. We hope that we shall do better in our endeavor in creating much better enabling conditions for our children.

On Tuesday, 25 May we had a commemoration of **Africa Day**. **Africa Day** is the annual commemoration of the May 25, 1963 founding of the Organization for African Unity (OAU). On this day, leaders of 30 of the 32 Independent African States signed a founding charter in Addis Ababa, Ethiopia. In 2002 the Organization for African Unity established its own successor, the African Union (AU) in Durban. However, the name and date of Africa Day has been retained as a celebration of African unity.

Hon. Speaker, in 14 days time, starting on the 11 June, the world's most popular sport will be played in South Africa. All of us have been waiting patiently for a long period for this tournament and as a country we have done our preparations. We have demonstrated that as a country we have the necessary capacity to host huge events. We have successfully hosted 2009 FIFA Confederations Cup and the final draw for 2010 FIFA World Cup. As a country we are confident that our National Squad which has undergone a serious revamp will make us proud during the Soccer World Cup. We must also congratulate Bafana Bafana for its outstanding performance against Bulgaria during Monday, 24 May 2010.

Indeed Honourable Speaker, as we all know, football is more than a game, it is a great unifying force, the former State President, Dr Nelson Mandela said, it can help "us uphold the values of tolerance, of inclusiveness and reconciliation, and of non-racialism and peace that are still dear to all of us today".

As Setsoto Municipality we must be counted amongst those that are welcoming visitors to our country and wish all the teams well and again we would like to urge all South Africans to support Bafana Bafana so that we can be able to emerge victoriously as the country. The FIFA 2010 Soccer Spectacular is finally on our shores, "**FEEL IT, IT IS HERE.**"

On the 16 June we shall be commemorating the **African Child Day**, a world-wide celebration that will focus international attention on the needs of African children. The commemoration coincides with the date of the massacre of demonstrating Soweto schoolchildren and somewhere else within our country by South African police on the **16th June in 1976**. We must ensure that we use this as an opportunity to educate our youth to be more responsible like the 1976 generation. We would like to urge the current generation of young South Africans to face new challenges and defend their nation's hard-won democracy and to stay away from crime and drugs. We are in the process of finalizing our preparations for Youth Month Celebrations.

It is also a pleasure to further pronounce that on the 16 June 2010 we are launching officially Setsoto Youth Advisory Centre. The primary purpose of this centre is to empower our youth with information so that they can be able to access opportunities that we are having within our country.

Last year (2009), around this period the Reserve Bank announced that our economy was officially in **recession**, and we urged our people not to despair, indeed our people did not despair. Now our economy has recovered from recession.

Hon. Speaker, our economy has been growing quite impressively in post-apartheid years, there had been fourteen years of Gross Domestic growth and the rate of this growth increased from 2003. However, in spite of this, overall inequality has not been reduced.

The budget of the municipality is informed by the income that we expect from the households, businesses, and government departments in terms of service charges. There has been an increasing level in terms of outstanding debts. The high outstanding debt amount is chiefly attributed to households. The increase in outstanding debt inhibits the ability of the municipality to achieve its set objectives. For the Financial Year of 2010/11 we shall continue to be robust when it comes to collecting money that is due to the municipality in our endeavor to ensure that there is a decline in outstanding debt.

People who cannot afford to pay for their services must be registered so that they can be subsidized by government. It is one of the challenges that we are faced with, of people that are not paying for their services and we do not know why they are unable to register with government to be subsidized. We must be seen acting harshly against people who are not paying for their services because we are asking, tell us, why you are not paying for the services that you are getting from government so that we can be able to assist you. We are kindly appealing to our people to cooperate with us in this regard.

67 Minutes for Mandela

Madiba's birthday on July 18 is the high point of Mandela Day and the main aim is to ensure that people see every day as a Mandela Day. Everybody can utilise Madiba's legacy to start a movement for good, by giving 67 minutes to help a community.

Mr. Mandela has spent 67 years making the world a better place. We're asking you for 67 minutes." Nelson Mandela turns 92 on 18 July, and the call has gone out for people everywhere to celebrate his birthday, – by acting on the idea that each person has the power to change the world. We would like to urge all our people to devote 67 minutes of their time to make an imprint and help change the world around them.

Madiba will be honoured if we could use this as an opportunity to bring together people around the world to fight poverty and promote peace and reconciliation. As Setsoto Municipality we are equally determined to reach out at those families that are in desperate need of help and we must ensure that there is unity of our people hence that there is a program that has been planned for 67 Minutes for Mandela. We would like to invite all our people to join millions of people throughout the world in making 67 Minutes for Mandela a success.

The Local Government Turn Around Strategy identified that municipalities are faced with a serious challenge and they must reflect on their own performance and identify their own tailor-made turnaround strategies focused on achieving the following:

- Stable Councils with visionary and accountable leadership;
- Undertake appropriate set of powers and functions, identify and establish relevant agency arrangements with national and provincial government within current policy framework;
- Professional administration that supports the political vision contained in the electoral mandate;
- Properly constituted corporate services, technical services and financial management functions, including recruitment and skills retention policies ensuring ‘right people in the right job’
- Provision of basic services and ensuring every cent spent is well considered and accounted for as ‘value for money’
- Through the municipal Spatial Development Frameworks, each municipality is aware of and is able to guide the land use activity on every square meter and kilometer in its area of jurisdiction. The enactment of the Land Use Management Schemes (LUMS) will assist in this regard.
- Optimized revenue collection and improved billing, customer care, indigent and credit control policies – ‘balance the books’
- Work towards sustaining clean audit outcomes by 2014. Those that can achieve the target earlier must do so.
- Improved public participation and communication including effective complaint management and feedback systems.

Hon. Speaker, allow me to take this opportunity to reflect in detail our Draft Budget for the Financial Year of 2010/2011

The total budget of the municipality is anticipated at **R 379 million** which is going to be funded out of own revenue that we are billing on service charges and rates, grants and subsidies that are received from the National fiscus as part and parcel of sharing in the national wealth which is indicated in the freedom charter. The total own revenue is budgeted an amount of R 152 million while grants & subsidies have been budgeted an amount of R 227 million.

EXPENDITURE

The expenditure of the budget reflects the inputs that are going to be used in order to maximise services delivery as I have indicated earlier on. Expenditure is distinguished in terms of Operating Expenditure as well as Capital Expenditure. Operating Expenditure refers to the normal day to day expenses of the municipality and it has been allocated a total amount of R286 million, whilst Capital Expenditure refers to the building or acquisition of infrastructural assets of the municipality and it is allocated a total amount of R 93 million. Hon. Speaker, this implies that a total of 25% of our expenditure shall go towards capital expenditure and that represents an average increase of 85% from the current financial year (2009/2010), 75% shall therefore go towards operating expenditure and it has increased with an average of 18%.

OPERATING EXPENDITURE

Employee related costs have been allocated a total amount of R 81 million which represents 28% against the total operating expenditure and the budgeted increase is 7.8% which is slightly above the 7.7% National treasury benchmark. The remuneration of Councilors is allocated a total amount of R 8.3 million which represents an average increase of 13%.

The municipality has a low payment rate and for that purpose the amount that has been allocated to the provision for bad debts is a total amount of R 34 million. We shall call the “Payment Imbizo” in order to explore various ways of maximising our collection rate as low payment rate inhibits the ability of the municipality to deliver services.

The provision for depreciation is an amount of R 26 million. We have allocated R 15 million towards repairs and maintenance and the majority of our repairs shall go towards road maintenance.

We have allocated an amount R 10 million for serving of municipal debts. Bulk purchase which reflects electricity that the municipality buys for re-sale is allocated an amount of R 34 million.

Honourable Speaker, we have allocated a total amount of R14 million for the purposes of assisting poor households through indigent subsidies and this ensures that the poor are protected by this budget. The maximum indigent subsidy is an amount of R 1400 (government advice on the increase is awaited) of household income of all people that are older than 18 years of age. Households that fall within this category are urged to consult their Ward Councillors to assist them with registering for indigent subsidy.

TARIFFS

On the 15 March 2010 it was announced that the National Energy Regulator of South Africa granted Eskom's to increase the municipal tariff on bulk electricity by 28.9% and the municipality tariff increase for electricity is 20% across the board. All qualifying residents in the municipality will continue to receive the Free Basic Electricity (FBE).

Water tariff is budgeted to increase by an average of 10% and the increase is largely attributed to the high anticipated inputs costs.

Sewerage and refuse tariffs are budgeted to increase with only 5% respectively.

CAPITAL EXPENDITURE

The municipality has budgeted for the following capital projects which are funded through the Municipal Infrastructure Grant (MIG). Indeed Project Management and Contract Management skills are essential for successful delivery of these projects and we need to ensure that the three most important components which are Time, Cost and Quality are not compromised in the project Life Cycle. DBSA has deployed a specialist for advice and support in this field. The Project Management Unit (PMU) needs to run at full strength for the successful delivery of the projects. The following projects are approved for MIG funding for 2010/2011 financial year:

An amount of **R 2 550 000.00** has been budgeted for the purchasing of **mobile compactors** (refuse removal trucks) and an amount of **R 500 000.00** for **tipper** trucks.

An amount of **R 40 000** has been budgeted for the purchasing of Mass Containers.

In terms of the Waste Management Act, Council must draw up an **Integrated Waste Management Plan** to ensure effective delivery of the refuse removal service. The Final Integrated Waste Management Plan (IWMP) was submitted to Council and approved during August 2009.

On **Parks and Cemeteries**, we have planned to develop at least **one park per unit** per year as a priority. This development would depend on **external funding**. An amount of **R 600 000.00** was made available in the budget for the 2008/2009 financial year for the development of parks.

Another priority is the greening of areas and possible donation of trees is negotiated with the Department of Tourism, Environment and Economic Affairs. These trees must then be donated to residents that are prepared to plant and care for these trees.

An amount of **R 200 000.00** has been budgeted for the development of **Tennis/Netball courts**.

An amount of **R 600 000.00** is made available for the provision of fencing at the cemeteries.

An amount of **R 1 000 000.00** is made available for the purchasing of a **Back Actor** (TLB) for use at the cemeteries.

An amount of **R 180 000.00** has been budgeted for the provision of services at the cemeteries, e.g. Toilets and water facilities.

We have budgeted an amount of **R 196 500.00** for the purchasing of **Lawn mowers, Weed eaters and equipment** for use at the parks. This purchasing would depend on **external funding**.

An amount of **R 400 000.00** has been budgeted for the purchasing of a **Tractor** for utilization at the parks.

The maintenance of community/town halls as well as the property of Council must also be seen as a priority to ensure that the assets of Council stay as an investment to Council.

Maintenance has been done and the work is still in progress at Matwabeng Community Hall, Matwabeng Police Station, Public toilets in Senekal, Toilets at Clocolan/Hlohlolwane cemeteries, Mapenyadira Community Hall and the Sport Stadium in Marquard. An amount of **R 168 000.00** has been made available for the purchasing of tools and equipment. This development would depend on **internal funding**.

We have budgeted an amount of **R 865 000.00** for new township establishment at Ficksburg with a total of 3000 sites that will be available for residential, business, churches and for Municipal usage. We have put a timeframe of not later than 30 June 2011 for this massive development.

Hon. Speaker there is also a plan to facilitate the construction and development of sites for medium and high cost houses in Clocolan where there are 60 sites readily available. This plan will require from us an amount of **R 20 000.00** to have it completed not later than 30 June 2011.

Local Economic Development (LED) Projects

Within the next financial year, the following projects were identified as lead projects in our strife to create jobs and fight poverty in our communities. Honourable Speaker, our former President would depict South Africa as having two economic divides: one that is rich and the other that is poor and predominantly Black. We intend to undertake Economic Regeneration Studies or feasibility studies and implement or commission the following projects flowing from our LED and Tourism Strategies.

• Development of Emerging Businesses	R100 000.00

We are currently looking at best modalities of Public Private Partnership (PPP) with and establishment of Municipal Entities to operate the Deemster Farm for an Integrated Dairy Project of which the Free State Department of Agriculture has already committed an amount of R2, 5 million for the development of the designs by German companies. Another project envisaged to be operated as an entity is the Meqheleng Peach Project and an Ad-Hoc Committee has since been established to look into the financial viability and sustainability of the project. In the words of John Maxwell, I still maintain that "Visionary People see the triumph before the prize is won."

Hon. Speaker, we have budgeted an amount of **R1, 128 million** for our interns to acquire skills and work experience in the fields of Financial Management, Information Technology, Human Resources, Auditing, IDP and Local Economic Development. A further amount of **R3, 343 million** is budgeted for training and learnership in the areas of Road Construction, waste Management, Electricity, Water Services, Fire Fighting and Community Services.

Youth Development

A society without young people is an incomplete society and we have found it extremely appropriate to budget an amount of R677 000, 00 for youth development with primary focus on the following areas: education, sports, entrepreneurship, arts and culture. The modalities will be and details will be addressed during implementation phase.

Farm dwellers

We are aware of working conditions of farm dwellers. It is therefore necessary for us to create a platform for engagement to deal with challenges that our farm dwellers are faced with. We must translate our policies into action by responding directly to the challenges that our farm dwellers are faced with. Hon. Speaker for the end of first quarter of our new Financial Year we have planned to have a Summit to deal specifically with the challenges that our farm dwellers are faced with. For the Financial Year of 2010/2011 we have an amount of **R 2.5 million** budgeted for our farm workers that are unable to pay for electricity and water.

Let me reiterate in the words of Dr King, "Injustice anywhere is a threat to justice everywhere. We are caught in an inescapable network of mutuality, tied in a single garment of destiny. Whatever affects one directly, affects all indirectly. Never again can we afford to live with the narrow, municipal "outside agitator" idea. Anyone who lives inside the Setsoto Local Municipality can never be considered an outsider anywhere within its bounds."

We would like to commend the majority of our councilors and officials who continue to serve our people with integrity and dedication. Keep up the good work that you are doing. We must also warn those that are not performing their duties that they will bear the consequences of their laziness. There comes a time when the cup of endurance runs over, and men are no longer willing to be plunged into the abyss of despair. I hope, sirs, you can understand our legitimate and unavoidable impatience. We can no longer postpone the hunger of the People.

With that Honorable Speaker, I will now formally wish to invite Hon. Councilors to adopt our IDP linked Budget for the Financial Year of 2010/2011 in terms of section 24(1) of the Municipal Finance Management Act, 2003 (Act No 56 of 2003) and dully informed by our IDP and the Municipal Turn Around Strategy.

REPORT : MUNICIPAL MANAGER

INTRODUCTION & OVERVIEW

In terms section 16 of the Municipal Finance Management Act No. 56 of 2003, read in conjunction with circular 28 issued by the National treasury the mayor must table the draft budget of the municipality for the purposes of inviting inputs from various stakeholders in terms of the draft budget.

The budget shall be advertised and the budget road shows shall also be undertaken in order to invite inputs from various stakeholders (E.g. Community). The budget inputs shall then be taken into account and a second draft shall be tabled at least 30 days prior to the start of the financial year for recommendation to the council for approval.

Note should be taken that the current draft budget is tabled at least 30 days before the start of the new financial year for approval based on the requirements as per new Municipal Budget and Reporting Regulation No. 32141 which was promulgated in the Government Gazette on the 17th of April 2009.

OBJECTIVE

The objective of the draft budget is for approval of the draft budget for 2010/11.

RECOMMENDATIONS:

1. That the draft budget of the municipality for the financial year 2010/11 and indicative for the two projected outer years, 2011/12 and 2012/13 be approved as follows:

- 1.1 Operating revenue by source;
- 1.2 Operating expenditure by vote;
- 1.3 Capital expenditure by vote;
- 1.4 Capital funding by source.

2. That the tariff structure as reflected for the 2010/11 be approved.

3. That the measurable performance objectives for revenue from each source reflected in the indigent equity area be approved for the budget year 2010/11.

After lengthy deliberation on the Budget, Cllr Tsolo proposed that the Budget be recommended to Council with amendments and was seconded by Cllr Oljohn.

Minutes Council Meeting: 27/05/2010

The Mayor was given the opportunity to present his Budget Speech whereafter each political party was given an opportunity to make inputs.

Clr Bester from FF+ indicated that the Turn Around Strategy was a wish list and further indicated that in two months there will be no salaries for the employees. She also talked of the increase on property rates with 6% and there are more than 300 objections against evaluation roll which will be attended in the next month as well as the increase of electricity and refuse removal by 5%. She indicated that legal fees were not budgeted for in this financial year. She also talked of that there was a promise in the last financial year budget that there will be a decline in outstanding debts instead it has increased and she voted against the budget.

Clr Makara from PAC indicated he expected a budget that would emerge from recession, he indicated that the budget was designed to stabilise the community and only to calm the fears of the haves. He further indicated what they want was to see was a budget which has proper systems and capable of delivering of services efficiently and effectually to meet the basic needs of the people. He further indicated that there is no significant improvement in health, Roads, Parks and Sport facilities. He also indicated that Community is awaiting houses. He also indicated there is no water in some areas what he can see is only dumping sites around our townships because of shortage of machinery and fleet. Lastly he indicated that farm dwellers are most hated communities which are ignored living without descend services and indicated that since the Mayor in his speech has included them and urged the Mayor that their inclusion to this budget should not be a song. Clr Du Toit from DA indicated that Setsoto Municipality has reached a gross road whereby the Chief Financial Officer is staked about the financial situation of the institution. He urged Management to give preference to the officials when coming to salaries because they are the one working. He shared the sentiment of the Mayor that the institution is faced with critical challenges of not providing descend services to their communities. He also agreed with Clr Bester statement that Council should not consider servicing the community with the promise that they are going to engage in robust collection of debts when they have appointed someone calling himself a lawyer who cant even do collection work. He also indicated on Page 15 of the budget some of the tariffs has been hijacked and he was skeptic as to whether was the public made aware of such hijacks because they did not appear during Mayoral budget road shows. He indicated it is a disgrace in the townships whereby the community is experiencing problems of the spillages and dumping sites all over in the townships. He lastly indicated this Council has dismally failed he further indicated he wont be suppressed if this Council goes to section 139 (Administration). He indicated DA was left with no option but to vote against the budget.

Clr Zim from ANC saluted members during this “people driven budget speech”

He said that indeed this budget marks a significant stride towards changing for better the lives of both sector of our constituencies in the township and town. It has taken into consideration a hands-on approach on the people’s needs and champion the fast tracking of sustainable service delivery.

He urged acknowledgement that during the recent financial year we were met with critical service delivery challenges (i.e. water scarcity, sewer spillage, unbearable roads and storm water due to heavy rain falls we previously received, and rare refuse collection both in town and township) we therefore plead and call to all our people to assist us collecting R226 M outstanding debt. With it we can turn-around this Municipality in a week’s time.

He indicated that people have spoken and vigorous action will unfold during 2010/2011 financial year. With the budgeted R446’825’393.00 for 2006/2011 (pg 57-62). **“REOLE LE TLO THUNYA, BATHO BA TLA THEOLETSA NTSHETSO PELE YA DITSHEBELETSO TSA MANTLHA”**

He then said that there shall be:

- Improved roads and storm water in our township
- Decent sanitation
- Decent recreational facilities for our children

- Actual greening on parks in the township for children to play

He requested members to join the hands in order to realise 5 key priority areas in our manifesto.

He lastly said that budget is indeed (ABC) Activity Based Costing Budgeting. It reflects on Baseline information and is an **accounting technique** that allows for the determination of the **actual costs.** **ANC supported the budget.**

EXECUTIVE SUMMARY

INTRODUCTION

The draft budget 2010/2011 was drafted taken into consideration the following pieces of legislation into consideration, *Constitution of the of the Republic of South Africa, Municipal structures act, Municipal systems act, Municipal finance management act, Division of Revenue Act, PPPFA, Competition act, Property rates act, National credit act, Basic Conditions of Employment Act, Labour Relations Act, Skills Development Act, Skills Levies Act, Employment Equity Act, Occupational Health and Safety Act, Compensation for Occupational Injuries, Budget related Circulars, and All Municipal Policies*

In drafting the budget the municipality has taken into consideration the requirements of section 18 of the Municipal Finance Management Act no. 56 of 2003. The foregoing section requires that the budget of the municipality should be based on a realistic anticipated revenue, however strict cash flow control should be applied during the financial year 2010/2011 in order to enable the municipality to meet its legislative obligation.

DRAFT BUDGET OVERVIEW: 2010/2011

The total draft budget for the year 2010/2011 is an average of R 379 million which is funded out of own income (e.g. service charges) and grants & subsidies. Grants & subsidies accounts 60% towards total revenue of the municipality while own income is anticipated to contribute 40%.

The draft budget is anticipated to increase with an average of 29% from the approved budget 2009/2010. The increase is directly attributed to grants that are attributable to the municipality in terms of Division of Revenue Act 2010.

INCOME OVERVIEW

Property rates is anticipated to contribute an amount of R 21 million while user charges for services which is constituted by Water, Electricity, Refuse, and Sewerage

EXPENDITURE OVERVIEW

Employee related costs have been allocated a total amount of R 81 million and it is anticipated contributes a 28% towards total operating expenditure. The municipality have not made any allocation towards vacant posts that are new. Old posts that are vacant as a result of resignations or death are catered for in the budget.

Remuneration of councillors is allocated an average of R 8.3 million which represents an increase of 13% from the previous budget year (2009/10).

Working capital reserve (Bad debt provision) is anticipated to be an amount of R 37 which is based on an average collection of 60% on property rates and user charges for services. However the foregoing budgeted amount will most probably not be sufficient to cover the total increase in the outstanding debt.

Depreciation is anticipated to increase by an average of 59% from the previous financial year (2009/10). The increase is attributed to the full implementation of GRAP whereby assets that were not individually depreciated shall be depreciated accordingly.

Repairs and maintenance is anticipated to be R 15 million and it shall contribute 5% towards operating expenditure. Repairs and maintenance has declined with an average of 30% from the previous financial year. The biggest culprit towards the decline is the roads and storm water. The other contributing factor is the anticipated reduction in repairs and maintenance based on the anticipated fleet to be acquired.

Interest of external borrowings is anticipated to be an amount of R 10 million which is based on the anticipated capital loans to be acquired. Grants and subsidies given which represents indigent subsidies is allocated an amount of R 15 million which represents an increase of 23% for the previous financial year (2009/10). The municipality in its endeavour to reduce costs it has tried to reduce the general expenditure by an average of 5%.

Bulk purchases (Bulk Electricity) is anticipated to be an average of R 34 million and the municipality has taken into cognisance the increase that was granted to Eskom by NERSA in terms of the electricity increase.

TARIFFS

The tariff for electricity is budgeted to increase with an average of 20% while tariff for water is budgeted to increase by an average of 10%.

The increase on electricity is informed by the general increase that is granted to Eskom by NERSA in terms of electricity increase.

The increase in water is based on the anticipated increase in the water chemicals and other utensils as a result of the high input costs (e.g. electricity increase) by manufactures and suppliers. The increase is also aimed at supplementing the asset infrastructure network within the water services.

Sewerage and Refuse shall increase with an average of 5% respectively.

All other tariffs are anticipated to remain unchanged in an effort to reduce the burden on household budgets. In an effort to ensure consistence and to broaden the tax base the municipality is anticipating introducing additional tariffs for the buying and selling of municipal land as well as renting of municipal properties.

BUDGET ASSUMPTION

The draft budget 2010/2011 is based on the assumption that if all things are constant the general future budget growth for the financial year 2011/2013 and 2012/2012 shall be 5% respectively.
