Contract Data resolts and Contraction

Specific data, which together with these General Conditions of Contract, collectively describe the s grisks, liabilities and obligations of the contracting Parties and the procedures for the administration of the Contract.

Contract Price

The price to be paid for the performance of the Services in accordance with the Pricing Data.

A calendar day.

Defect

A part of the Services, as performed, which does not comply with the requirements of the Contract.

Any measurable, tangible, verifiable outcome, result or item that must be produced or completed;

<u>Employer</u>

The contracting party named in the Contract who employs the Service Provider.

An event which is beyond the reasonable control of a Party and which makes a Party's performance of its obligations under the Contract impossible or so impractical as to be considered impossible under the circumstances.

Key Persons

Persons who are named as such in the Contract Data who will be engaged in the performance of the Services.

Others

Persons or organizations who are not the Employer, the Service Provider or any employee, Subcontractor, or supplier of the Service Provider.

<u>Parties</u>

The Employer and the Service Provider.

Period of Performance

The period within which the Services are to be performed and completed, commencing from the Start Date.

<u>Personnel</u>

Persons hired by the Service Provider as employees and assigned to the performance of the Services or any part thereof.

Personnel Schedule

A schedule naming all Personnel and Key Persons.

Pricing Data

Data that establishes the criteria and assumptions that were taken into account when developing the Contract Price and the record of the components that make up the Contract Price.

Service Provider

8. COMMENCEMENT, COMPLETION, MODIFICATION, SUSPENSION AND TERMINATION

8.1 Commencement of Services

 - c) any delay in the performance of the Services which is not due Provider's default;
 - d) Force Maieure; or
 - suspension.
- The Service Provider shall within 14 Days of becoming aware that a delay may occur or has 8.2.3 occurred, notify the Employer of his intention to make a request for the extension of the Period of Performance to which he considers himself entitled and shall within 30 days after the delay ceases deliver to the Employer full and detailed particulars of the request.

The Employer shall, within 30 Days of receipt of a detailed request, grant such extension to the 8.2.4 Period of Performance as may be justified, either prospectively or retrospectively, or inform the Service Provider that he is not entitled to an extension. Should the Service Provider find the decision of the Employer to be unacceptable he shall, nevertheless, abide by such decision in the performance of the Services and the matter shall be dealt with as a dispute in terms of Clause 12.

8.3 Force Majeure



PROPOSED SCOPE OF WORK FOR THE IMPLEMENTATION OF THE FULL WATERBORNE SEWER SYSTEM (BUCKET ERADICATION PROGRAMME) FOR SENEKAL/MATWABENG AND MARQUARD/MOEMANENG

- 1. We refer to the meeting held on 27 June 2006 at the offices of Setsoto Municipality in Ficksburg between your Mr TJ Makelefane and Mr M Kohrs at Setsoto Local Municipality's requirements regarding the implementation of the full waterborne sewer system for Senekal/Matwabeng and Marquard/Moemaneng utilizing funds from the Municipal Infrastructure Grant (MIG) by ISA and Partners Consulting Engineers were outlined.
- 2. The key issues discussed at the aforementioned meeting as well as the meeting held on 10 July 2006 were the following:
 - i) Setsoto Municipality will require ISA and Partners to present proposals for approval at each stage of the project life cycle, namely, design, tender, construction and completion;
 - ii) ISA and Partners would be required to complete all the necessary funding and other applications, including technical and other reports, on behalf of Setsoto Municipality to the funding agents (MIG and other) as well as regulatory authorities like the department of Water Affairs and Forestry (DWAF) and the Department of Environmental Affairs (DEAT);
 - iii) ISA and Partners would be required to investigate all possible sanitation alternatives in light of the bulk water supply shortages faced by Senekal and Marquard, Mr Kohrs mentioned that a pilot project had been implemented in a school in Setsoto for a recycling system involving on site sanitation;

Check Water in Senekal-

- The bulk water supply problems in Marquard were being addressed by another firm and ISA and Partners would not be required to attend to this. The bulk water supply problem in Senekal may require some investigation and ISA and Partners. The bulk potable water storage capacity is sufficient in both Senekal (9 Ml) and Marquard $(5.8 \text{ M}\ell)$;
- A new residential area in Marquard for 635 sites would require both water and sewer v) infrastructure and this was to be attended to in the applications;
- 13 July (**vi)** ISA and Partners would investigate the existing sewage treatment facilities and sewer pumpstations and make recommendations for their upgrading;
- Mr Kohrs mentioned that Setsoto Municipality had commissioned Aermap Ltd. of Pretoria to undertake the aerial surveys of all the towns in Setsoto and ISA and Seinoto Taron Partners could contact them directly for survey information; P () Soft 12
- If any record information was required for the two towns ISA and Partners could viii) contact either KweziV3 or Ninham Shand for this information.
 - ISA and Partners were to undertake site visits to Senekal/Matwabeng and ix) Marquard/Moemaneng to investigate the situation on the ground in the week of 3-7July 2006 with a follow up meeting with Mr Kohrs on 12 July 2006.
- After the aforementioned site visits to Senekal/Matwabeng and Marquard/Moemaneng by Messrs CN Kimaru and SR Makubo, ISA and Partners was able to prepare the scope of work for the implementation of the full waterborne sewer system for Senekal/Matwabeng (3414) and Marquard/Moemaneng (3359) for approximately 6,773 erven including other essential attendant work like the upgrading of the sewage treatment facilities in Senekal and Marquard and the construction / upgrading of sewer pump stations in both towns. Please refer to the attached Annexures A1, A2, B1 and B2 for details of the scope of works.
- 4. As a result of the site investigations in Senekal/Matwabeng and Marquard/Moemaneng, ISA and Partners have made the following observations about the current state of water and sewer infrastructure:

- There are discrepancies with the population figures provided in the IDP document (Reviewed IDP 2005/2006) and the physical numbers of people in both Senekal/Matwabeng and Marquard/Moemaneng. It is necessary to verify the exact number of people in the two towns physically to enable accurate figures to be captured for planning purposes, an example of this is the flow of 2.6 Ml/day flowing into the Senekal sewage treatment works (STW) which is the flow for about 31,700 people, while the official statistics indicate that there are 28,094 people residing in Senekal and Matwabeng.
- ii) The submersible sewer pumps installed in the three existing sewer pumpstations in Senekal and Matwabeng frequently break down and are very expensive for Setsoto Municipality to maintain. We would propose that they be upgraded to include a reinforced concrete screening channel and the submersible pumps be replaced by end suction centrifugal Gorman Rupp sewer pumps with the attendant electrical and mechanical improvements;

- i) The Marquard oxidation ponds are extremely overloaded and they have exceeded their design limit of 1.0 Ml/day, a new 1.9 Ml/day activated sludge STW needs to constructed as a matter of urgency before any more toilets can be connected to the sewer reticulation system;
- The submersible sewer pumps installed in the two existing sewer pumpstations in Moemaneng frequently break down and are very expensive for Setsoto Municipality to maintain. We would propose that they be upgraded to include a reinforced concrete screening channel and the submersible pumps be replaced by end suction centrifugal Gorman Rupp sewer pumps with the attendant electrical and mechanical improvements;
- There is a need for at least two more new sewer pumpstations to serve all the residents of Moemaneng, these two new sewer pumpstations would be constructed in the new configuration with a reinforced concrete screening channel and end suction centrifugal Gorman Rupp sewer pumps.
- 5. A request was made to Mr Charles Marais of KweziV3 to provide ISA and Partners with record information on Senekal and Marquard (refer to attached email copy) and he confirmed receipt of the email telephonically. We are waiting for the information to be made available to us once it has been compiled.
- 6. Aermap Ltd. have provided us with a quotation for providing the aerial survey information for Senekal/Matwabeng and Marquard/Moemaneng (refer to the attached letter). Please clarify what Setsoto Municipality paid Aermap for before we place our order for them to proceed.
- 7. We have also attached three plans with options for the construction of new toilet structure for your information. Please inform us which of the three options A,B or C setsoto would like to proceed with for the new toilets construction. The toilets currently constructed in Matwabeng and Marquard are similar to our proposed option A, except for the concrete roof.
- 8. We would appreciate your comments on our proposed scope of works as a matter of urgency to enable us to proceed with the submission of Business Plans and Technical Reports to MIG and DWAF. The latest available information from these two agencies is that they are looking to make funds available to those municipalities that put forward their total BEP needs forward early from other sources, it is therefore critical that we proceed and finalise Setsoto Municipality's BEP needs as soon as possible.
